If driving from Richmond, take a right on Courthouse Road.* Go about 9 miles, then take right on East Main St (VA-208 East/VA-22 East). Go about 2 miles, then turn right at Industrial Dr (State Rt 780). The Betty Queen Center is about 0.6 mile on the right. Large parking lot is to the left of the building.
